6. Cancellation / Booth size adjustment

Should there be any cancellation of the booth by the exhibitor, the exhibitor should notify the organiser in writing 3 months before the show opens. All deposits paid are non-refundable. If the exhibitor cancels the booth 2 months before the exhibition, a written notice is required to be made to the organiser and the exhibitor is liable for FULL participation fee payable.
